Duty on current and future PlayStation consoles at &#128185; the end of last y  
ear, though the Japanese electronics giant turned down the olive branch at the t  
ime. In an &#128185; effort to secure approval from regulators, including the F  
TC and CMA, Microsoft went on to sign an agreement with Nintendo &#128185; to b  
ring the series to the company&#39;s future consoles. It also came to terms with
